Acceptable Use of Technology: Acceptance Process

To help protect our systems and data, it is important that the Cincinnati State community understand and acknowledge the <u>Acceptable Use of Technology</u> policy. Every employee (full & part-time), consultant, contractor, and vendor who has access to Cincinnati State systems will complete this process annually. This policy can be accepted using the Cincinnati State Information Security Awareness *organization* within MyCState/Blackboard. This process should take less than twenty minutes to complete.

MyCState/Blackboard Organization

To access the acceptance process:


- Log in to <u>MyCState/Blackboard</u>
- Click the College Community tab
- Click Information Security Awareness link in the My Organizations module.

Acceptance Process


